5. Electronic bids must be submitted through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 11:00Hrs on 1<sup>st</sup> November 2022 (2079/07/15). Bids received after this deadline will be rejected.
6. Bidder shall be required to deposit the cost of bidding document fee (as specified in the table below) and scanned copy (PDF format) of the Bank deposit voucher should be submitted along with the electronic submission of the bid files.
7. All bids shall be accompanied by a Bid Security for the amount as specified in the table. Bidders are required to submit a separate bid security guarantee issued only by the bank stated in Public Procurement Act and its Regulation with latest amendment shall be accepted by the Employer. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, which shall be valid for 30 days beyond the validity period of the bid.
